TERMS & CONDITIONS

GENERAL

In no event shall Restaurant & Catering Australia be liable for any direct, indirect or consequential losses suffered by any party as a result of the operation of the CPR certification program.
- b. Statements made by the committee of experts are put forward by Restaurant & Catering Australia as an expert opinion established by due process.
- c. The operation of the CPR certification programs shall be governed by the law of New South Wales. Restaurant & Catering Australia and the certificate holder/applicant irrevocably submit to the exclusive jurisdiction of the courts of New South Wales and the New South Wales division of the Federal Court of Australia, and the courts of appeal from them.

2. APPLICATION

- a. To obtain restaurateur certification an individual must complete, sign and submit the relevant restaurateur certification application and forward it (with the required attachments) to Restaurant & Catering Australia.
- **b.** By submitting the registration form the applicant agrees that:
 - i. The information contained within the application is accurate
 - ii. The individual will abide by these terms and conditions
 - iii. The certification fee, if required will be paid to the association by credit card or cheque
 - iv. All certification fees are non-refundable.

3. WITHDRAWAL

- a. The certificate holder may withdraw from the certification program at any time. Restaurant & Catering Australia request confirmation by e-mail and on receipt of this will be remove the certificate and all references to it from the website.
- **b.** Restaurant & Catering Australia reserve the right to withdraw certification in cases where it has reason to believe that a certification holder is deliberately acting against the best interests of the program.

4. RIGHT TO USE RESTAURANT & CATERING AUSTRALIA CERTIFICATION MARK LOGO

- a. Restaurant & Catering Australia certification mark is intended to be a trademark of Restaurant & Catering Australia.

- d. When an individual ceases to hold certification, the permission to use Restaurant & Catering Australia certification is withdrawn. Un-certified restaurateurs must cease their use of the CPR as soon as is reasonably practicable following their notification that certification has been withdrawn.
- e. The Restaurant & Catering Australia certification trademark must not be juxtaposed to other symbols or text in such a away as to show a connection with
- f. Restaurant & Catering Australia reserves the right to change its trademark at any time at its discretion. When Restaurant & Catering Australia changes the Restaurant & Catering Australia certification trademark, existing use of the unchanged version is permitted to continue in the short term, but users should transition to the changed version as soon as possible.

5. APPEALS

- a. A certified professional restaurateur, an individual applying, or an individual re-applying for certification, has a right of appeal to the Association if their certification is removed or application is refused. An appeal can be made against any decision made by the Association other than a decision as to whether the applicant has met the required minimum criteria for accreditation.
- b. An appeal must be lodged in writing with Restaurant & Catering Australia no later than fourteen (14) days after the notice of the Association's decision has been given.
