TERMS & CONDITIONS OF ENTRY

Entrants may enter a maximum of two categories. If entering two categories then entry fees will be charged per category.

The fees applicable to enter for financial members for R&CA are \$125.00 inc GST. Non-members can enter for a fee of \$175.00 inc GST. The nomination fee includes 1 x ticket to the Wine List Awards Event. Additional tickets can be purchased for \$45.00 (members) or \$60.00 (non-members) per person by contacting the events team on 1300 722 878 or events@restaurantcater.asn.au.

Nominees withdrawing their entry prior to the evaluation will be refunded the entry fee less \$50.00 (set administration fee). No refund will be issued once the business has been evaluated under the system.

To be eligible for judging, restaurants must submit a copy of their current menu and a copy of their wine list along with the official wine list nomination form. Payment must be received at the time of nomination. Judging is based on submission only. The judges' decision is final and no correspondence shall be entered into.
